In compliance to the directions of the Hon'ble Allahabad High Court, in Writ Petition No. 66861 of 2009, filed by Harish Chandra Ramkali Charitable Trust, 12 GDA Officers Colony, Patel Nagar-I, Ghaziabad, UP, the application of the said trust seeking approval of the AICTE for treating all its four institutes as Integrated Campus, alongwith new H.R. Institute of Engineering & Technology, 7th km. Stone, Delhi-Meerut Road, Morta, Ghaziabad (UP) in accordance with the norms on the date of application, has been processed.

2. An Expert Committee consisting of the following members was constituted as per Approval Process Handbook, 2008:-

- Prof. L.D. Patel, Director C.U. Shah College of Pharmacy & Research, Wadhwan (Gujarat)
- Prof. S.K. Singh, Delhi Technological University, Delhi
- Dr. S.K. Goel, Associate Professor, G.B. Pant University of Agriculture & Technology, Pantnagar.

The above Expert Committee visited the Institutions on 30.06.2010 and submitted its report.

3 The report of the Expert Committee was examined in the AICTE and it was noted that Committee had given its report in case of some of the institutions under reference, based on the norms prescribed under AICTE's Regulations for the year 2010-

11, however, the matter was to be dealt with as per the norms prescribed for the year 2008-09.


4 The meeting of the Expert Committee referred to in paragraph 2 above, was convened on 05.08.2010, in accordance to the finding of the AICTE indicated in paragraph 3 above. After the deliberation in the said meeting, the Committee submitted its supplementary report.

5 The reports of the said Expert Committee (i.e. report after visit and supplementary report) were placed before the Standing Committee of Experts, consisting of following members in accordance with the provisions of Regulations notified vide F. No. 37-3/Legal/2006 dated 14.09.2006:

- a. Dr. D.N. Reddy, VC, JNTU, Hyderabad.
- b. Dr. Kripa Shankar VC, UP Technical University, Lucknow.
- c. Prof. Sandeep Sancheti, Director, NIT, Surthkal, Karnataka.
- d. Prof. D.S. Chauhan, VC, Uttarakhand Technical University, Dehradun-RC Member.
- e. Dr. M.K. Hada, Advisor (Approval), AICTE HQrs.-Convenor.

The above said Standing Committee of Experts, in its meeting held on 10.08.2010 at AICTE Office, considered the above said reports in the light of the order of the Hon'ble High Court under reference and recommended to the AICTE to integrate four Institutions viz. (1) H. R. Institute of Technology, Ghaziabad, (2) H. R. Institute of Pharmacy, Ghaziabad, (3) H. R. Institute of Hotel Management, Ghaziabad and (4) H. R. Institute of Professional Studies, Ghaziabad and to consider the Trust's proposal for opening of new engineering College namely, H.R.Institute of Engineering and Technology, Ghaziabad, **as standalone** giving the advantages on land area as directed by the Hon'ble Court without allowing any other benefit under integrated campus, since it will not be in the best interest of professional growth of both institutions i.e. existing and new engineering college. The recommendations of this Committee have been accepted.

6 Accordingly, in terms of the Regulations notified by the Council vide F.No. 37-3/legal/2006 dated 14/09/2006, I am directed to convey the approval to the Harish Chandra Ramkali Charitable Trust, 12 GDA Officer Colony, Patel Nagar-I Ghaziabad, (UP), to integrate four Institutions viz. (1) H. R. Institute of Technology, Ghaziabad, (2) H. R. Institute of Pharmacy, Ghaziabad, (3) H. R. Institute of Hotel Management, Ghaziabad and (4) H. R. Institute of Professional Studies, Ghaziabad into integrated campus and to H. R. Institute of Engineering & Technology, Ghaziabad, 'as standalone' Institution for a period of 2 years with effect from the date of issue of this letter for getting affiliation with concerned University and fulfilling State Government's requirements for admission. The above Institutions shall have the approved intake as under:





7. The above stated approval is subject to the condition that all Institutions shall fulfill the following general conditions:

- a. The Society/Trust/Institution shall obtain necessary affiliation / permission from the concerned affiliating University as per the prescribed schedule of the University/ Admission authority etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE.
- b. The management shall provide adequate funds for development of land and for providing related infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
- c. The admission shall be made only after adequate infrastructure and all other facilities, including the availability / recruitment of the required faculty are provided as per norms and guidelines of the AICTE.
- d. The admissions shall be made in accordance with the regulations notified by the Council from time to time.



- e. The curriculum of the course, the procedure for evaluation / assessment of students shall be in accordance with the norms prescribed by the AICTE and concerned affiliating university where ever applicable.
- f. The management of the Institution shall not close the Institution or the institution shall not discontinue any course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the Council.
- g. No excess admission shall be made by the Institution over and above the approved intake under any circumstances. In case any excess admission is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution.
- h. The institutions shall not have any collaborative arrangements with any Indian and / or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution.
- i. The Institution shall not conduct any course(s) in the field of technical education in the same premises / campus and / or in the name of the Institution without prior permission / approval of AICTE. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
- j. The institution shall not conduct any non-technical course (s) in the same premises / campus under any circumstances. In case any violation is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution.
- k. The institution shall operate only from the approved location, and that the institution shall not open any off campus study centers / extension centers directly or in collaboration with any other institution / university / organization for the purpose of imparting technical education without obtaining prior approval from the AICTE. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
- l. The tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students / guardians of students in any form. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
- m. The accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or persons authorized by it.
- n. The Director / Principal and the teaching and other staff shall be appointed in given time frame and selection shall be done according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time to time.
- o. The mandatory disclosure in format as prescribed in Approval Process Handbook issued from time to time is required to be hosted on the Institute website as per directions in the AICTE website failing which, action would be initiated as per the rules and regulations of the AICTE.




- p. The technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses / programs being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education. The mandatory disclosure information shall be put on the Institution Website. The information shall be revised every year with updated information about all aspects of the institution.
- q. It shall be mandatory for the technical institution to maintain a Website providing the prescribed information. The Website information must be continuously updated as and when changes take place.
- r. If a technical Institution fails to disclose the information or suppress and / or misrepresent the information, appropriate action as per the notified regulations shall be initiated against the Institution.
- s. All the laboratories, workshops etc. shall be equipped as per the syllabi of the concerned affiliating University and shall be in operational condition before making admissions.
- t. A library shall be established with adequate number of titles, books, journals (both national & international), E-subscription, etc. as per AICTE norms.
- u. A computer center with adequate number of terminals, printers etc. shall be established as per AICTE norms.
- v. AICTE may carry out random inspections round the year for verifying the status of the Institutions to ensure maintenance of norms and standards.
- w. AICTE may also conduct inspections with or without notifying the dates to verify specific complaints, to verify adherence to AICTE norms & standards, and to verify any mis-representation, violation of norms & standards, mal-practices etc.
- x. The Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid from the Central or State Government.
- y. In the event of a student / candidate withdrawing before the starting of the course, the wait listed candidates should be given admission against the vacant seat. The entire fee collected from the student, after a deduction of the processing fee of not more than Rs. 1000/- (Rupees one thousand only) shall be refunded and returned by the Institution / University to the student / candidate withdrawing from the program. It would not be permissible for Institutions and Universities to retain the School / Institution Leaving Certificates in original to force retention of admitted students (See Public Notice AICTE/ DPG/ 03(01) /2008)
- z. The Institute shall take appropriate measures for prevention of ragging in any form, in the light of directions of Hon'ble Supreme Court of India in Writ Petition No. 656/1998. In case of failure to prevent the instances of ragging by the Institutions, the Council shall take appropriate action as per the notified regulations.



aa. The institution shall provide barrier free environment and toilets for physically challenged persons.

8. The Management of the Institute shall strictly follow further conditions as may be specified by the Council from time to time. The Council may withdraw the approval, in case it observe any violation of the above conditions and / or non adherence to the norms and standards prescribed by the Council, mis-representation of facts and submitting factually in correct information to it.
